In order to reserve a party:

- Reservations must be made onsite, in advance.
- **A Parksdirect Account must be established and a non-refundable reservation fee & \$150.00 security deposit must be paid at the time of booking.** The security deposit will be returned to the client providing that you leave on time, leave the area clean and all rules and regulations listed on the contract were followed. If the client has followed all rules, the facility will request that the deposit be refunded to the client. For a deposit paid by credit card, the deposit refund will be issued as a credit to the credit card account. For a deposit paid by cash or check, the deposit refund will be issued by check. A check refund may take 3-4 weeks to process. No cash refunds will be allowed.
- The parent or legal guardian must be present with an ID and the child's birth certificate or approved age verification document to establish an account and to make reservations.

Only one birthday party reservation will be allowed per customer, per facility, per day.

- The parent or legal guardian must be present with an ID and the child's birth certificate or approved age verification document to establish an account and to make a reservation.
- **A parks direct account must be established. A non-refundable reservation fee & \$150.00 security deposit must be paid at the time of the booking.** The security deposit will be returned to the client providing that you leave on time, leave the area clean and all rules and regulations listed on the contract were followed. If the client has followed all rules, the facility will request that the deposit be refunded to the client. For a deposit paid by credit card, the deposit refund will be issued as a credit to the credit card account. For a deposit paid by cash or check, the deposit refund will be issued by check.
