To receive informational mailings on new development projects in your community, your organization must register with The Maryland-National Capital Park and Planning Commission. 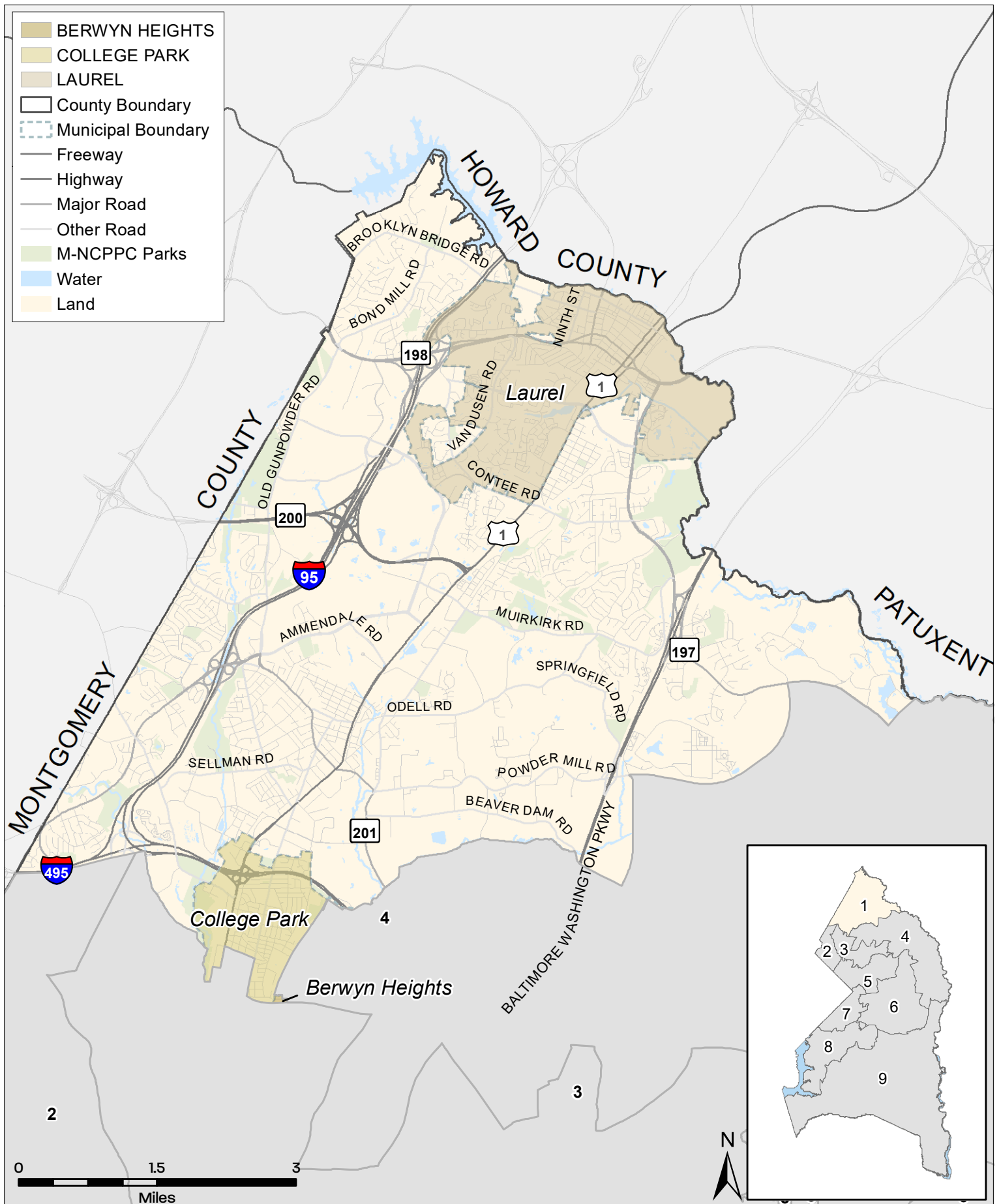

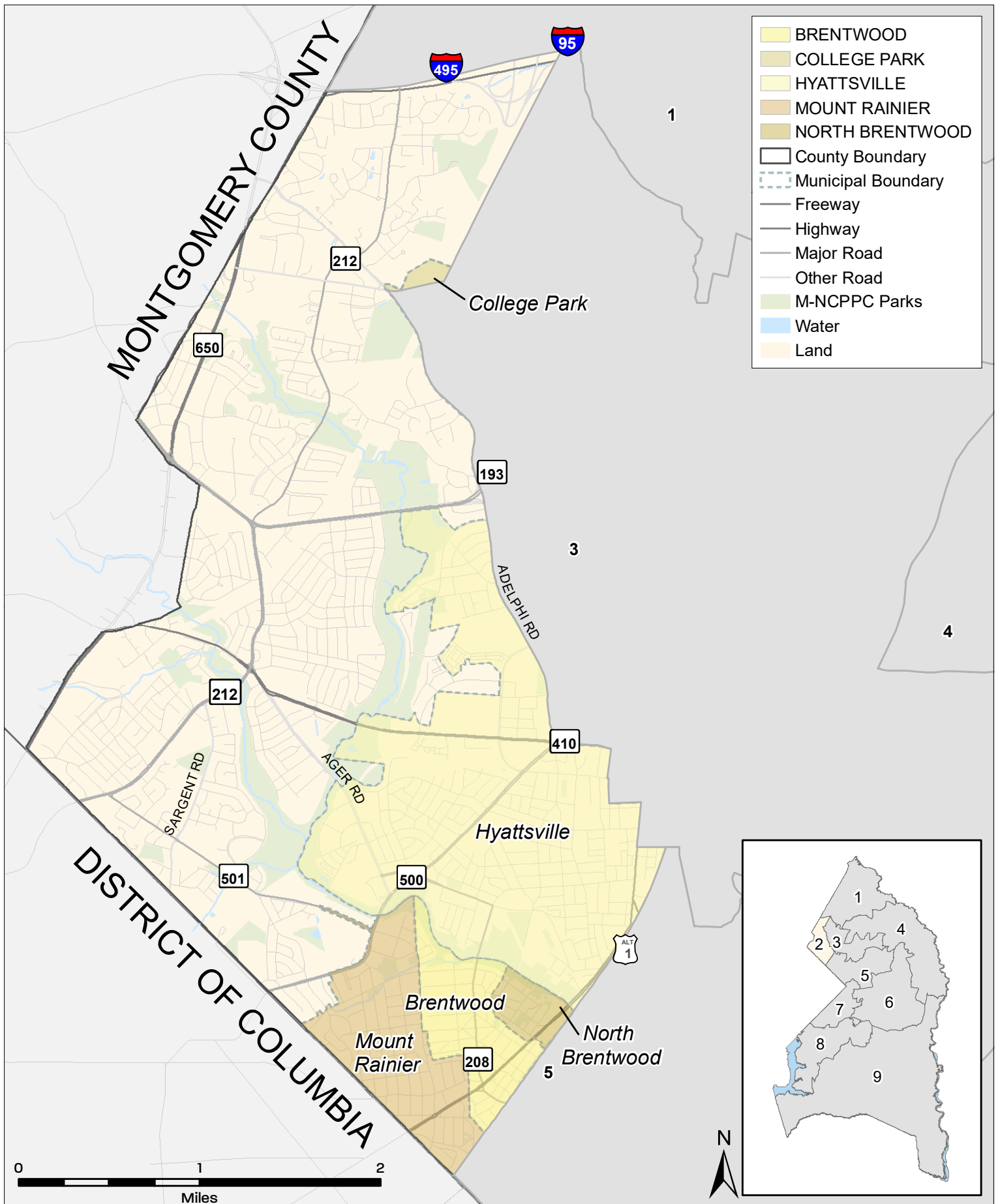

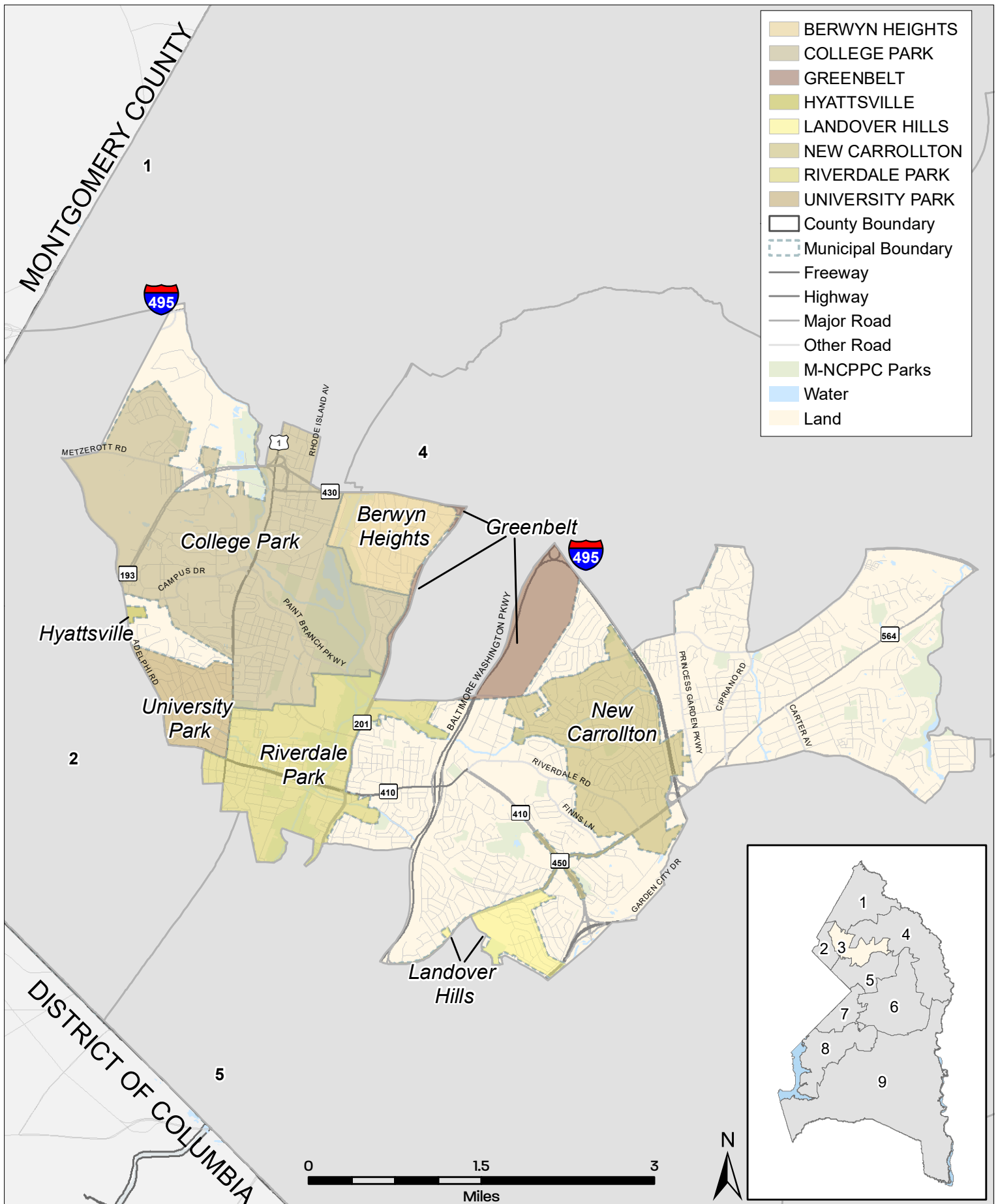


Council District 1 Prince George's County, MD



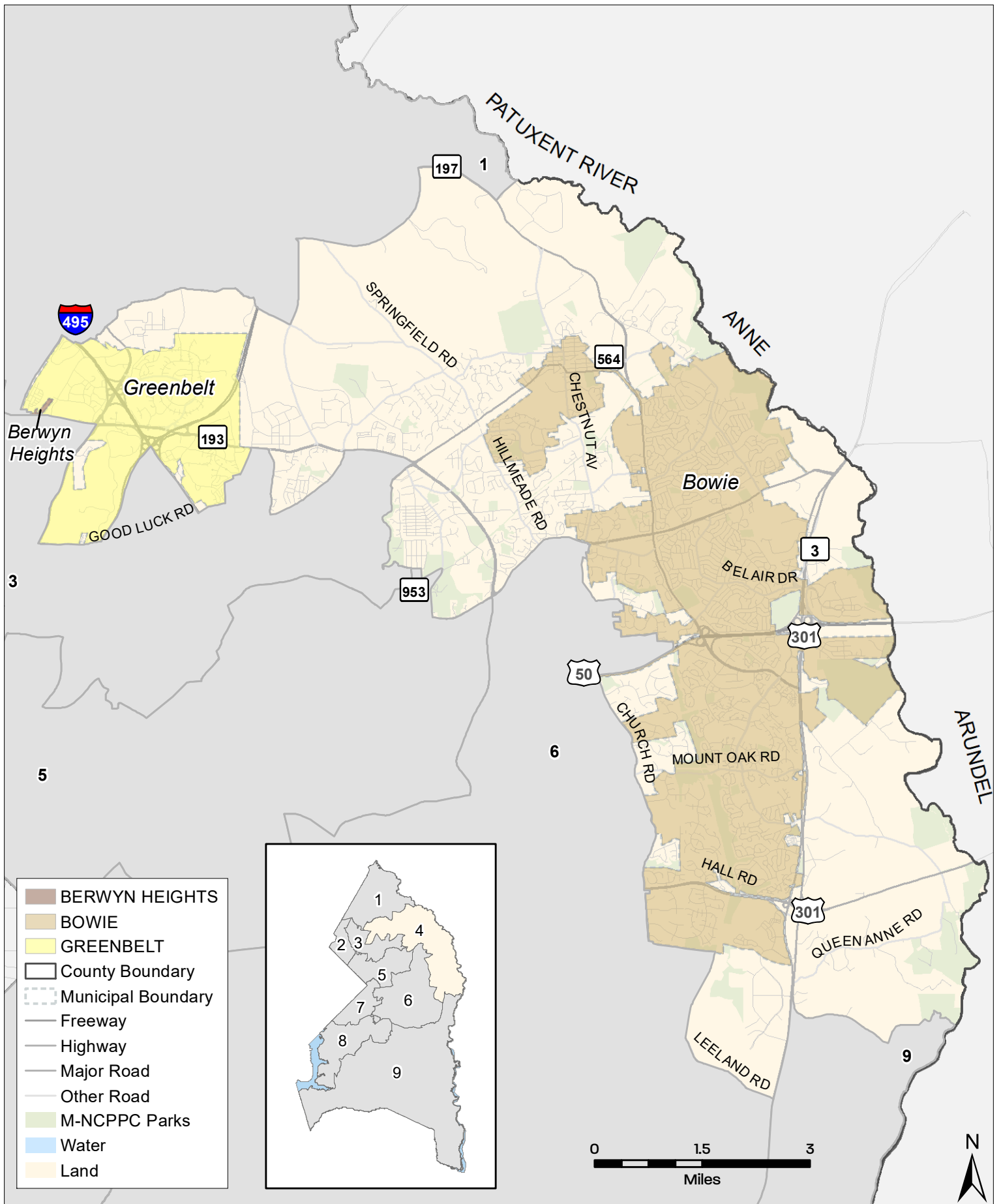


Council District 2
Prince George's County, MD

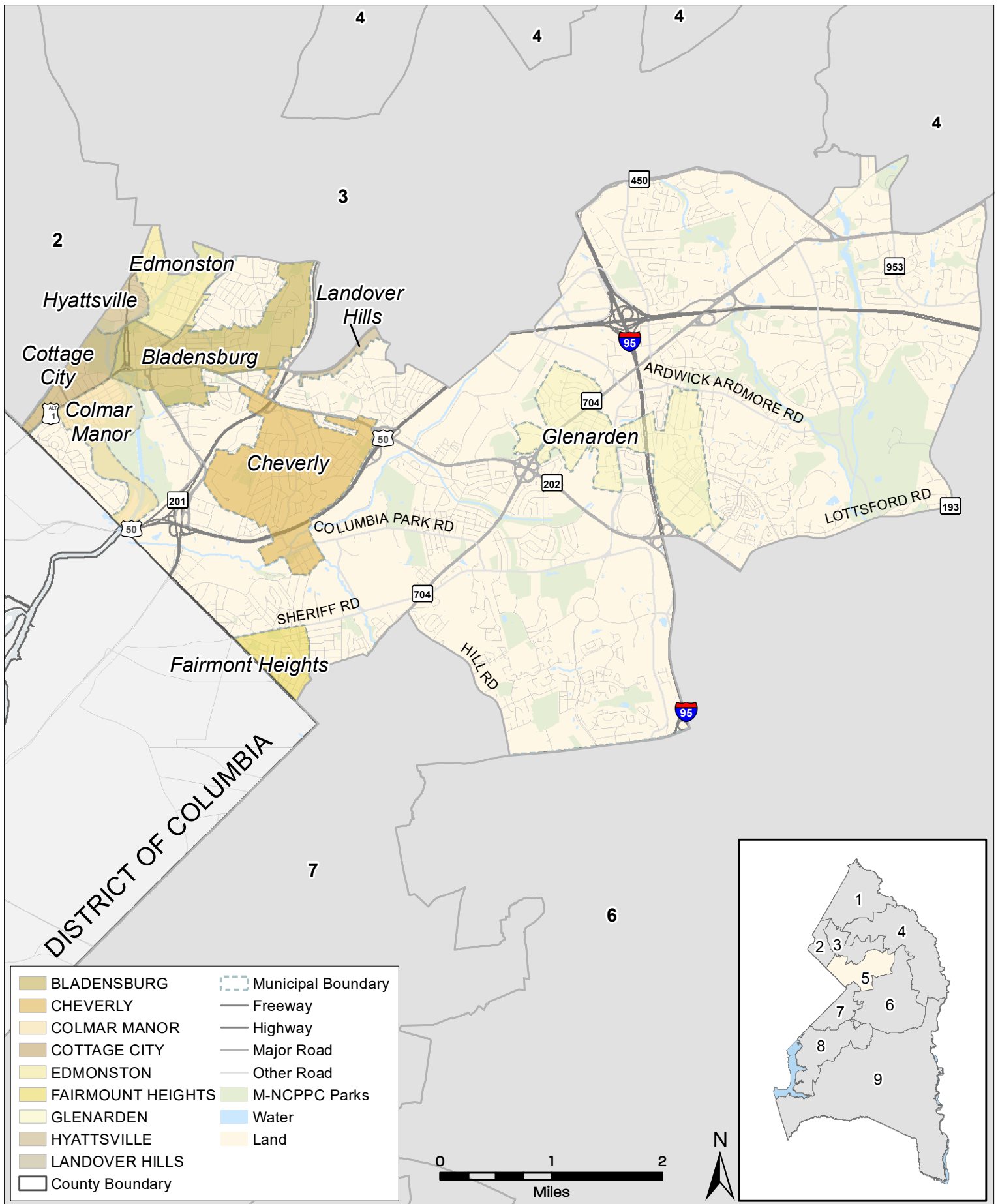


Council District 3
Prince George's County, MD

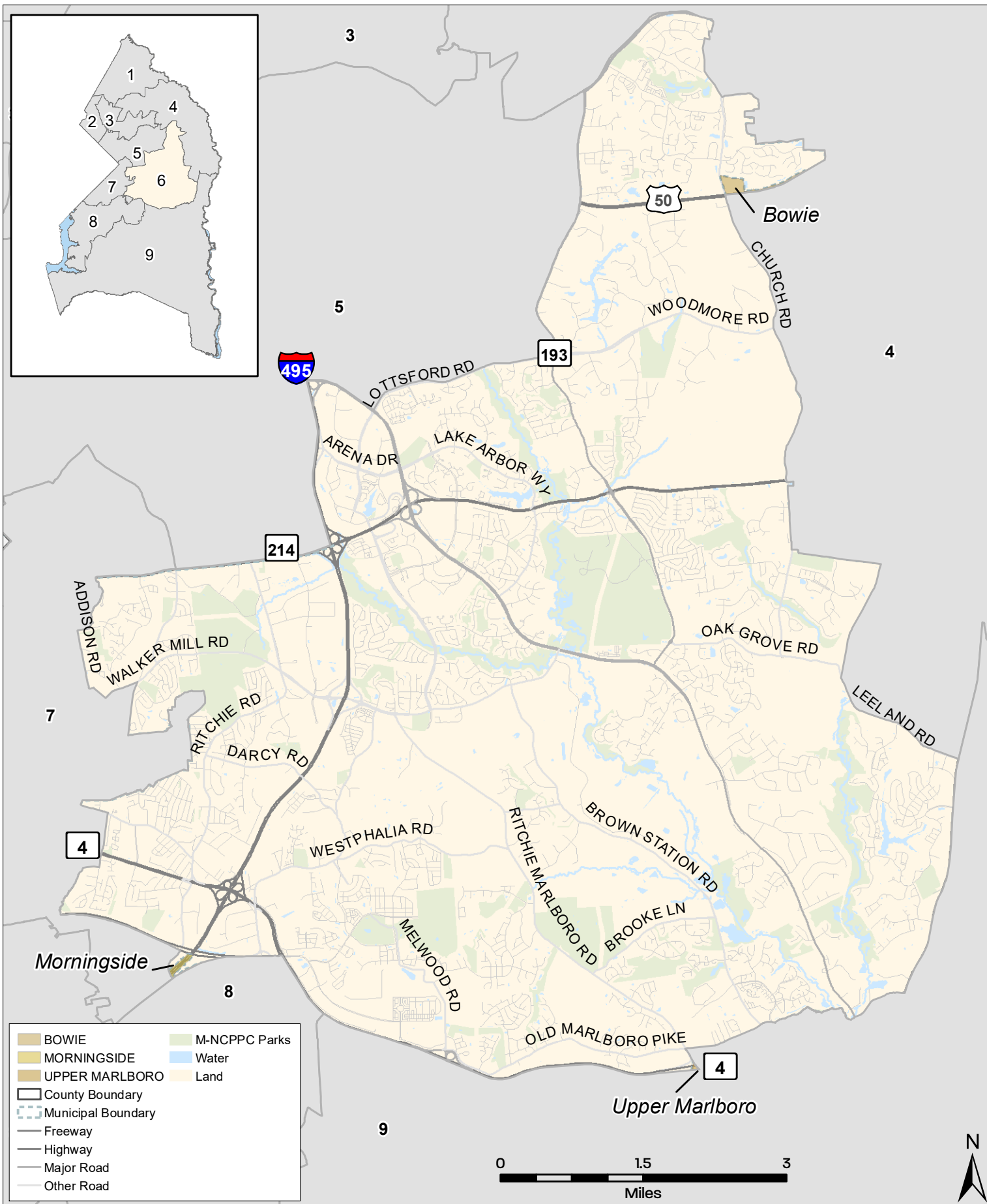




Council District 4 Prince George's County, MD

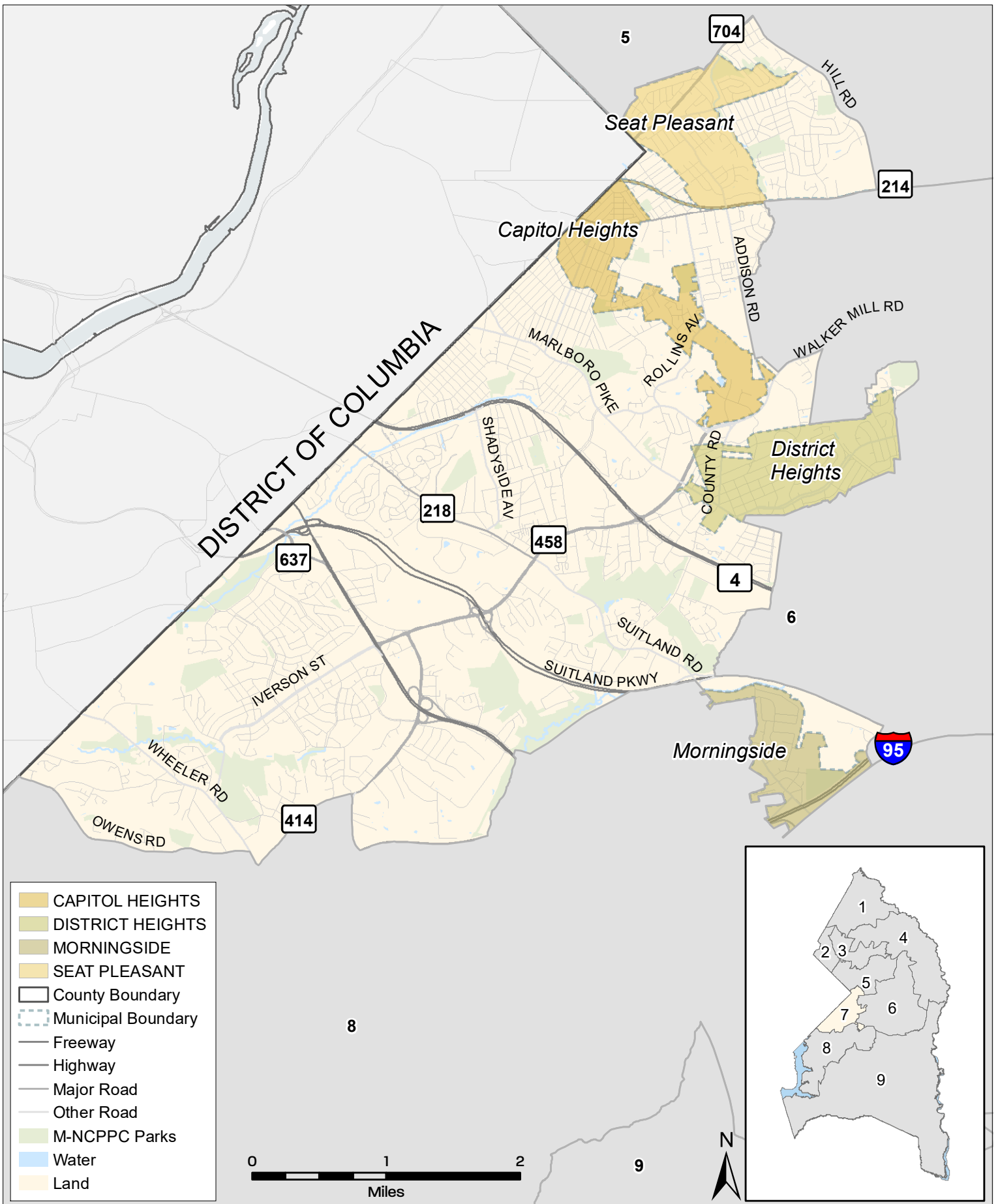


Council District 5 Prince George's County, MD

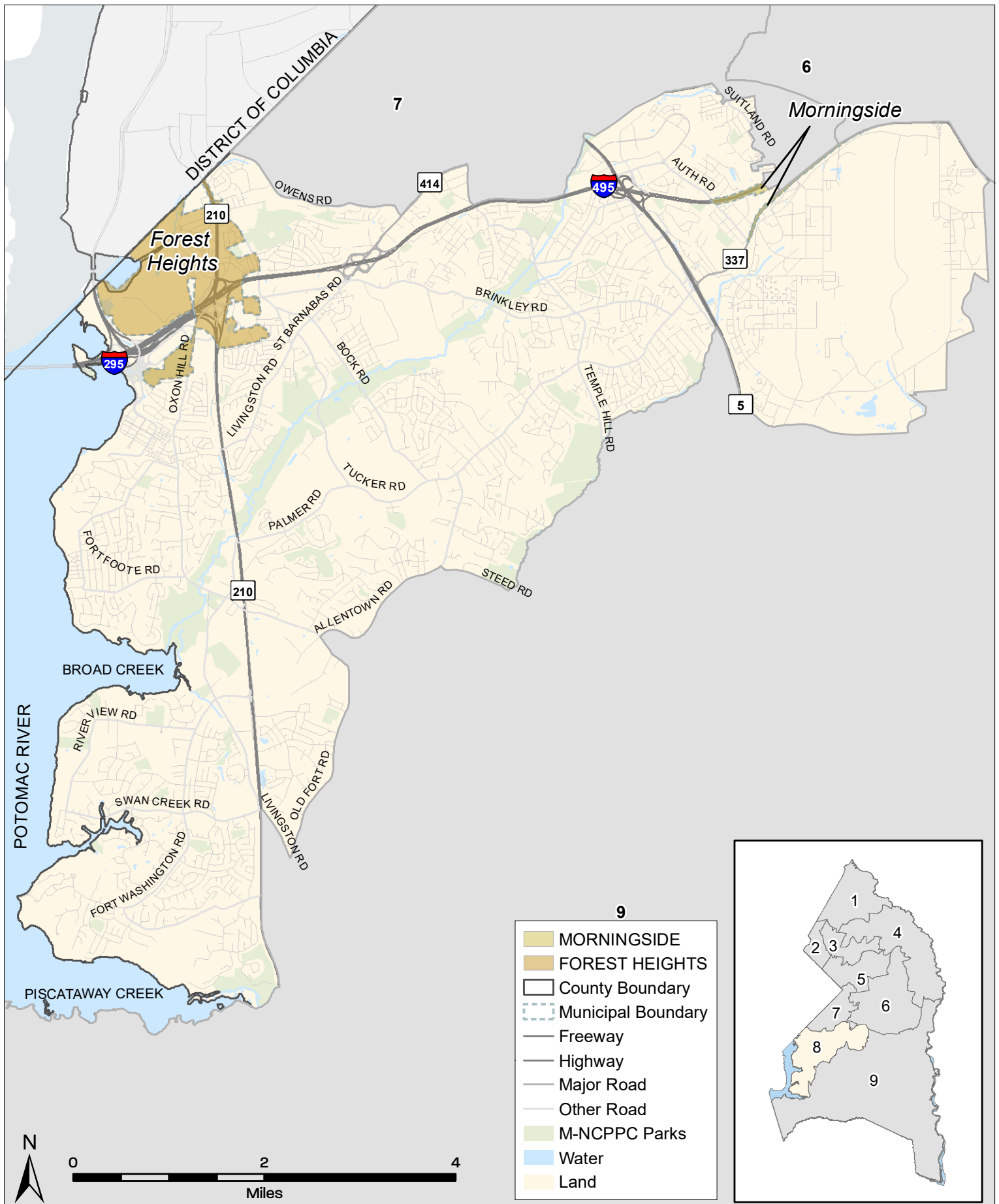


Council District 6 Prince George's County, MD

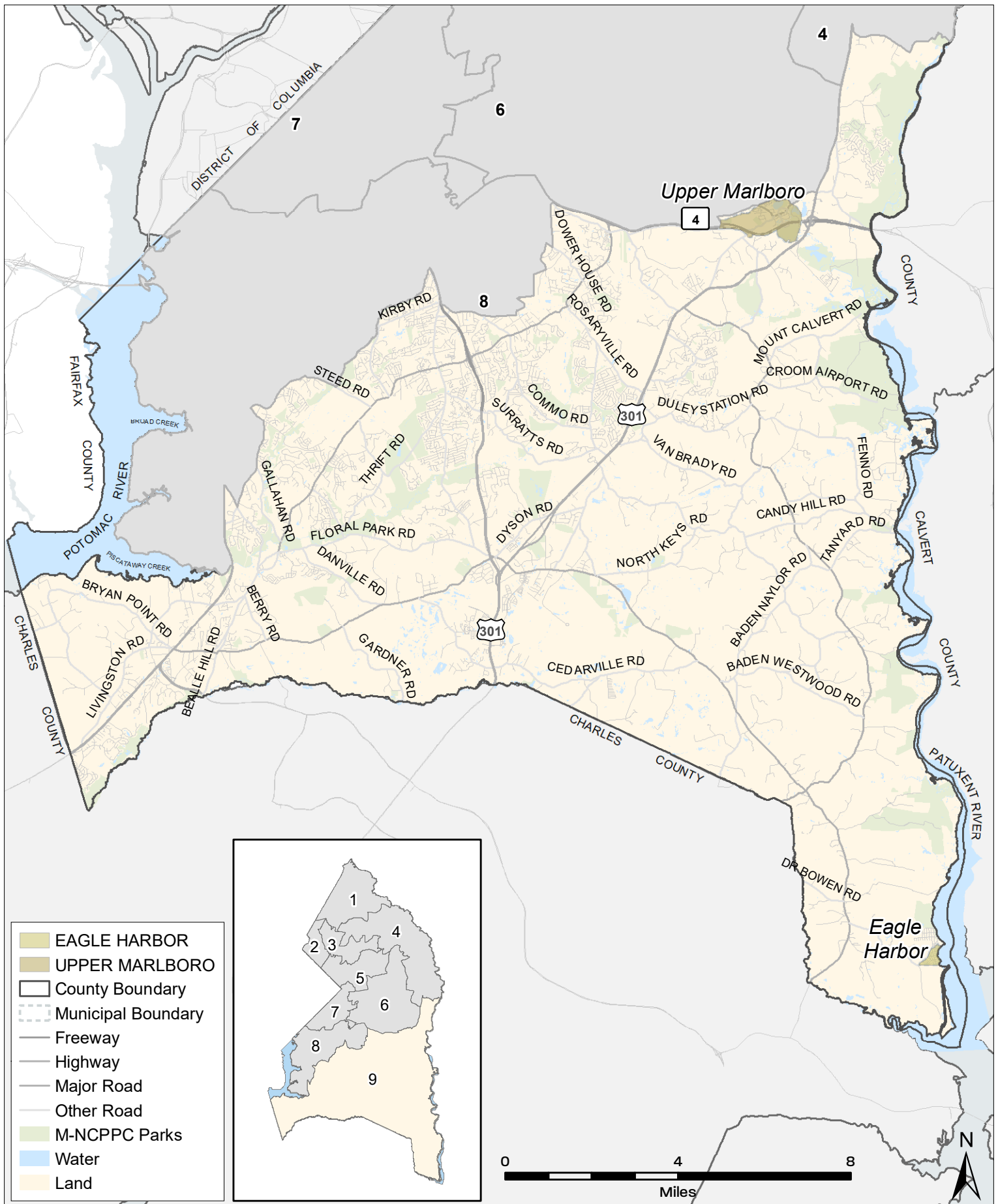




Council District 7 Prince George's County, MD
