



Sample Agreement to Amend Private Recreation Facilities Agreement

THIS AGREEMENT TO AMEND PRIVATE RECREATION FACILITIES made this _____ day of, by and between THE MARYLAND-NATIONAL CAPITALPARK AND PLANNING COMMISSION, a public body corporate, hereinafter referred to as the "Commission and_ name of landowner a Maryland corporation hereinafter referred to as the "Developer."

WHEREAS, the Developer and the Commission, parties hereto, entered into a Private Recreation Facilities Agreement dated____, recorded at Liber_____folio_____,among the Land Records of Prince George's County for the purpose of providing certain recreation facilities as required through the approval of Preliminary Plan No._____for the subdivision entitled_____, located in the _____Election District of Prince Georges County, Maryland ("Subject Property") from the Developer to the Commission for park and recreational purposes; and

WHEREAS, within the intervening time since the execution of the said Recreational Facilities Agreement dated__, the Developer and the Commission agree that certain revisions to Detailed Site Plan No._____for the subject property have been approved by the Commissionthat reflect an alteration in the type, location and construction sequencing of certain of the recreationalfacilities upon the subject property, all of which has resulted in the need to revise the terms of the above-referenced Private Recreation Facilities Agreement; and

WHEREAS, the Commission has stated the reason(s) why it is necessary to amend and;

WHEREAS, THE Developer and the Commission, parties hereto, have agreed to so amend the said Recreational Facilities Agreement dated_____, by the execution of this Agreement to Amend;

NOW, THEREFORE, THIS AGREEMENT WITNESSETH, the said parties hereto, their successors and/or assigns, in consideration, of the premises aforesaid and for other good and valuable consideration, do hereby agree as follows:



1. That notwithstanding anything to the contrary in this Agreement to Amend, the terms and conditions of the said Recreational Facilities Agreement dated—, remain in full force and effect.
2. That this Agreement to Amend shall be recorded among the Land Records of Prince George's County and recording fees to be paid by the Developer, his successors and assigns.
3. That the recreation facilities to be constructed by the Developer, and the location of same, along with the triggering events by which they are to be bonded and completed, are hereby amended as follows:
